1. Online Tender on e-Procurement Portal <https://cgmfpfedtenders.abcprocure.com> as in Annexure – I (Technical Tender) and Annexure - II (Financial Tender) are invited from eligible tenderers for the supply, installation, and hands-on training of machines required for MFP based processing units as per specification given in Section 1 by Chhattisgarh State Minor Forest Produce (Trading & Development) Cooperative Federation Limited.
2. Tender notice along with **Section 1, Annexure-I, II, III, IV and V** giving detailed specification / delivery schedule etc., can be seen and downloaded from Federation's website [www.cgmfpfed.org](http://www.cgmfpfed.org) and e-Procurement portal <https://cgmfpfedtenders.abcprocure.com> only.
3. (i) Tenders are to be submitted only online in the prescribed Tender Forms only for Technical Tender (Annexure – I) and Financial Tender (Annexure - II).  
(ii) The tenderer will propose in Financial Tender the **rate (inclusive of Basic Rate, G.S.T and Other Taxes if any should be mentioned)** F.O.R destination including all taxes i.e., Machines and Services Tax and surcharge and the Local Bodies Taxes if any on F.O.R destination basis. (Delivery locations (Destination) of all the items as mentioned in clause 4 below is provided in Annexure III.)

5. The Tenderer shall submit online Technical and Financial Tender in separate Technical Tender Envelope and Financial Tender Envelope respectively mentioned in **Annexure - IV**.
6. The tenderer should upload certified photocopies of all the documents required in this tender notice. The tender shall be accepted up to 15.00 hrs. on 28.06.2022 and Tender shall be opened online in this office only at 15.10 hrs. on 28.06.2022 even if it is a public holiday by the duly constituted Committee.
7. Decision of the Managing Director of the Federation to declare any of the tenderer to have or have not qualified in Technical Tender shall be final and binding on the tenderer. Intimation of decision of the competent authority shall be conveyed to the tenderers.

8. Financial Tender of only those tenderers who qualify in the pre-qualification shall be opened.
9. Earnest Money Deposit (EMD): The tenderer will have to make the online payment of EMD as shown in Clause 4 of the tender document. EMD amount as shown in Clause 4 of the Tender document will have to be deposited by the tenderer irrespective of the number of machines for which the tenderer is applying the tender for, the tenderer is free for apply for one, many or all the machines given in the Clause 4 of the tender document. The tender/s will summarily be rejected if there is any discrepancy in the amount of EMD that is required to be deposited. EMD has to be deposited through payment gateway service provider in any of the following ways -
  - A. **Credit Card / Debit Card (VISA / Master / Maestro Cards)** - The tenderer after selecting the option of the Credit Card / Debit Card (VISA / Master / Maestro Cards) make the online payment, as per the instructions of payment mentioned in the payment gateway.
  - B. **Net Banking** - Tenderer can make the payment only from the bank account in having net banking facility. 10. The rate offered by the tenderer in the Financial Tender will be valid up to forty-five days from the date of opening of the Financial Tender but not later than 75 days of opening of the Technical Tender.
11. Rate should be clearly mentioned in the Financial Tender in figures only. The tenderer can tender for the item category mentioned in clause 4 of this tender notice and pay the EMD accordingly.

## **12. Eligibility Criteria**

- i. The tenderer should be a Manufacturer of machines to be supplied or a Registered firm.
- ii. The tenderer shall have minimum Annual Turnover of INR 3 lakhs (three lakhs) in anyone (1) of the past three (3) years (i.e., FY 2019-20, 2020-21, 2021-22) preceding the Tender Due Date
- iii. The tenderer must have latest GST/VAT/Sales Tax Clearance certificate along with copy of Registration certificate under Sales Tax.
- iv. The tender from principal firm and authorized agent/dealer will not be accepted together.
- v. The tenderer must submit the blacklisting certificate indicated that their firm is not blacklisted from any Government Organization.
- vi. As per section 139A of the Income Tax Act, 1961, enclosing of scanned copy of PAN card is compulsory for the tenderer.
- vii. Enclosing of Scanned copy of Aadhaar Card issued by Unique Identification Authority of India. (UIDAI) is compulsory. Scanned copy of Aadhaar Card of Managing Director of the Company and in case of Partnership firm Aadhaar Card of at least two of

Partners required, in case of Hindu Undivided Family (HUF) Aadhaar Card of Karta and one adult family member is to be enclosed.

### **13. Person Authorised to Submit Tender**

- i. Person or persons signing the tender form shall state in what capacity he or she or they are signing the tender form e.g. as sole proprietor of the firm concerned or as Managing Director or Director or Secretary of Limited Company. In the case of partnership firm, the names of all the partners should be recorded and the tender form should be signed by all the partners or their duly constituted attorney having authority to bind all partners in all matters pertaining to the contract as recorded in the power of attorney or in the partnership deed. True copy of the Registered "Partnership Deed" should be uploaded along with the tender form failing which the tender shall be liable to be rejected. - ii. The person signing the tender form on behalf of another or on behalf of a Firm shall enclose with the tender form power of attorney or deed duly executed in his favour or the partnership deed giving him such power showing that, he has the authority to bind such other person or the firm, as the case may be in all matters pertaining to the contract. If the person so signing the tender form fails to upload the said power of attorney or partnership deed, his tender shall be liable for summary rejection. The power of attorney should be signed by all the partners in the case of partnership concerns, by the proprietor in case of a proprietary concern and by the person who by his signature can bind company in the case of limited company. In the case of Hindu undivided family, the power of attorney should be signed by the 'Karta' who by his signature can bind the family.

The decision of the Managing Director, Chhattisgarh State Minor Forest Produce (T & D) Co-operative Federation Ltd. shall be binding upon the supplier and in case of any article supplied is not being approved, then expenses or loss caused to M.F.P. Federation as a result of rejection or replacement of supplies, shall be entirely to the account of the supplier.
4. The Managing Director, Chhattisgarh State Minor Forest Produce (T & D) Co-operative Federation Ltd. or his duly authorized representative shall at all reasonable time access and examine the materials and workmanship of the machines.
5. In case machines other than of the approved quality, make or size are supplied, the same shall have to be replaced immediately by the supplier without extra cost. Any expenses or loss caused to M.F.P. Federation on whose behalf purchase has been made, shall be in account of the supplier.
6. The supplier should ensure that the machines are inspected to ascertain the quality material primarily. At the time of loading, the supplier should ensure that the packaging bubble wrap and seals are intact on all the equipment. The machines will be inspected by the person authorized by CGMFPFED at the time of delivery and if the machines are not found in conformity with the given specification / approved quality, make or size as per the technical specifications provided in Section 1 of the Tender document, the same will be rejected and the supplier shall have to replace the same immediately without any extra cost. Any expenses incurred / loss suffered by CGMFP Federation on this a/c shall be debited to the supplier's a/c.

**CGMFPFED can also conduct a joint inspection if required and in case joint inspection is not carried out along with the surveyor within the given time, it would be presumed that the complaints made by the consignees are quite genuine and loss sustained by the consignees, shall be recovered from the supplier.**



7. The CGMFP has the right to have a demonstration of the equipment/item in his premises. The supplier has to abide by this condition. The demonstration has to be arranged by the supplier at his own cost.
8. The rejected machines must be removed by the supplier from the destination wherever they may be, within fifteen days of the date of inspection. The Purchaser concerned will take care of such materials but in case of delay the purchaser shall not be responsible for any loss, shortage, damage, etc. If the supplier fails to lift the materials within the above prescribed period, extra storage charges will be recovered at the rate of five paise per bag per day.
9. The supplier shall be responsible for the proper standard packing so as to avoid damage under normal conditions of transport by road and shall ensure delivery of the materials in good condition to the consignee at respective centre. In the event of any loss, damage, torn / cut or any shortage found on checking / inspection of the materials by the consignee, the same shall be debited to the supplier's account.
10. The Proposed **rate (inclusive of Basic Rate, G.S.T and Other Taxes if any should be mentioned)** and will be valid up to 45 days from the date of opening of Technical Tender.
11. The Managing Director Chhattisgarh MFP Federation can repudiate the contract of supply at any time, at the risk and cost of the supplier, if the supplies are not made up to satisfaction of CG State MFP (T&D) Co-op. Federation.
12. The successful tenderer will have to submit a Performance security of equivalent to 3% of the Contract /Order value before the issue of award letter valid till 60 days beyond the period of expiry of the Warranty/ Guarantee period in shape of crossed Demand Draft/Pay order/Fixed Deposit Receipt/Bank Guarantee from a commercial bank in favour of the CGMFP Raipur, payable at Raipur. The performance security will remain valid till expiry of warranty period. This will be released beyond 60 days after completion of warranty period. If the security deposit is not deposited within the specified time, the supply order will be cancelled, the EMD will be forfeited and the tenderer may be blacklisted for future transactions with Federation by the Managing Director Chhattisgarh MFP Federation, Raipur for a maximum period of 3 years. No interest shall be paid by CG State MFP (T&D) Co-op. Federation on such security deposit.
13. Remittance charges on payment made to the supplier will be borne by the supplier.
14. Supply & Installation / Delivery Schedule: The supplies shall be made strictly as per the following schedule-
  - i. Delivery and final installation required: For Indian manufacturer - Within 15 days from the Date of issue of award letter or as specified in the supply order;

If the supplier fails to supply Machines according to the time schedule and specifications specified in firm order, it will be treated as breach of terms and conditions and will result in forfeiture of full/part EMD / Security Deposit by Managing Director, Chhattisgarh State Minor Forest Produce (T & D) Co-operative Federation Ltd., Raipur and further render the supplier responsible and liable for damage/loss specially the extra cost incurred by the purchaser for procurement of the unsupplied material from open market. The value of damage/loss will be assessed by the

Managing Director, Chhattisgarh State Minor Forest Produce (T & D) Co-operative Federation Ltd., Raipur and will be final and binding on the supplier. In addition, the supplier can also be blacklisted by the Managing Director, Chhattisgarh State Minor Forest Produce (T & D) Co-operative Federation Ltd., Raipur for future transactions with Federation for a maximum period of 5 years.

15. The Machines will be supplied/ installed at different places in the Chhattisgarh, which are listed in the tender in Annexure III.
16. Supply/ installation of Machines will be done by the supplier free of cost.
17. The cost of damage if any during transportation and installation will be borne by the supplier.
18. A warranty of one year will be given by the supplier for any manufacturing defect in the machines.
19. Any change / corrigendum/ extension of opening date in respect of this tender shall be issued through websites only and no press notification will be issued in this regard. Tenderers are therefore requested to regularly visit our website for updates.
20. **Penalty for Delayed Services / Liquidated Damages:** In case the firm does not complete the supply within the laid down agreed delivery period as per contract, liquidated damages will be charged @ 0.5% per week or part thereof subject to a maximum of 10% of the contract value. However, the CGMFP reserves the right to either further extend or cancel the contract after expiry of delivery date and recover the liquidated damages from the dues of the firm by legal means.

#### **21. Evaluation of Tender: Single bidding process is adopted**

##### **Pre-Qualification**

- i. Evaluation of Technical Tenders to assess their suitability against the laid down parameters in this tender notice
- ii. Tenderers must ensure that they enclose all original technical literature and detailed documentary proofs which specifically bring out the compliance of the equipment being offered against the technical specifications mentioned in the tender notice. If necessary, the Tenderers may be directed to give a presentation for evaluation by a technical committee constituted for the purpose.
- iii. In case it is not possible to verify compliance of equipment as per technical tender due to lack of adequate documents, in original no reference will be made to tenderer and the tender will not be considered further and treated as cancelled.

##### **Opening of Financial Tender**

- i. The price tenders of only those firms, found meeting the laid down specifications in pre-qualification and eligibility criteria shall be opened, evaluated, and considered further.
- ii. It is in the tenderers interest to include all relevant and detailed technical data as supporting documents along with their tender.
- iii. The Financial tender will be considered for total sum of all items specified in clause 4 of the tender notice. However the tenderer shall quote cost of each item specified else the bid will be rejected.
- iv. Lowest Financial proposal (L1) shall be declared successful tenderer.

- 22. Insurance:** As applicable in the case of imported machines. For indigenous item it will be responsibility of the supplier to supply the material in good condition on FOR basis without involving the risk of the purchaser. The equipment to be supplied will be insured by the vendor against all risks of loss or damage from the date of shipment till such time it is delivered at site of installation.
- 23. Payment:** Payment on bill basis after supply, satisfactory installation, commissioning, and performance of the equipment at designated locations in Chhattisgarh and after certification by the concerned.
- 24. Terms of Delivery:** FOR District Union locations in the state of Chhattisgarh (Details provided in Annexure-III), timeline and location may be amended at the sole discretion of the Managing Director, Chhattisgarh State Minor Forest Produce (T & D) Co-operative Federation Ltd.
- 25. Inspection After Receipt of Machines:** The inspection will be done by the Committee in the presence of the firm representative. The successful tenderer will have to provide at his own cost and arrangement technically qualified personnel at the consignee's location for joint inspection. These personnel must be able to unpack, assemble and demonstrate the use of the equipment fully and identified each Part/Machines supplied. Any consumables that are essential will be provided by the supplier free of cost.  
In case of receipt of materials in damaged condition the suppliers will have to arrange the replacement of machines free of cost. All expenses in this regard will be borne by the supplier.
- 26. Packing & Marking:** The packing and preservation of the supplied machines shall be roadworthy so that it may provide their safety during transit period. The supplier shall guarantee that the packing is strong enough to withstand the safety of the machines during transport. The packing should satisfy the security seal in the clearing warehouse and shall carry the fragile or other markings as required. All damages which may occur as a result of defective packing shall be borne by the seller.
- 27. Compliance Statement:** The firms must submit compliance statement-cum-technical tender in the format given in technical specifications and 3D drawings and machinery concept failing which their offer will be treated as incomplete and is liable to be rejected.
- 28. Guarantee /Warranty:** Comprehensive onsite warranty is required. Warranty Terms period will start from the date of installation of items. In case at installation stores/part of stores are found defective /damaged during or after delivery to consignee, the suppliers will replace or repair the store under warranty at consignee's location in India free of cost or if any case it is required to be sent back to the foreign manufacturer. Bank Guarantee equivalent to the cost of equipment is required to be submitted before lifting the store. All expenses in this regard will be borne by the supplier.
- 29. Dispute settlement:** The dispute arising out of this contract shall be subject to the jurisdiction of Indian laws & court at Raipur. Sole arbitrator is appointed by the MD, CGMFP and his decision will be final and binding to both parties (Supplier and Purchaser).
- 30. Training:** Supplier has to do technology transfer and skill enhancement / hands-on-training for the operation and handling of machine to operator. All expenses in this regard will be borne by the supplier

- 31. Price:** The price quoted shall be on firm and fixed basis and should be reasonable leaving no scope for any further negotiation on price. CGMFP is exempted from payment of excise duty. Hence, excise duty will not be paid to the firm. For sales tax, CGMFP is not authorized to issue Sales Tax Form C&D; CGMFP is exempted from payment of Custom Duty
- 32. Penalty for use of undue influence:** The seller should undertake that he has not given offered or promised to give directly or indirectly any gift, consideration, reward, commission, fees brokerage of inducement to any person in service of the Purchaser or otherwise in procuring, the contract or forbearing to do or for having done or for borne to do any act in relation or execution of the contract or any other contracts with the CGMFP for showing or for bearing to show favour or disfavour to any person in relation to the contract or any other contract in the CGMFP. Any breach of the aforesaid undertaking by the seller or any one employed by him or acting his behalf whether with or without the knowledge the seller or the commission of any offers by the seller or any one employed or acting on his behalf, as defined in Chapter-IX of the IPC, 1860 or the Prevention of Corruption Act, 1947 or any other Act enacted for the Prevention of Corruption shall entitle the purchaser to cancel the contract and all or any other contract with the CGMFP seller and recover from the seller the amount of any loss arising from such cancellation. A decision of the purchaser or his nominee to the effect that a breach of the undertaking had been committed shall be final and binding on the seller.  
Giving or offering of any gift, bribe or inducement or any attempt at any such act on behalf of the seller towards any officer /employee of the purchaser or to any other person in a position to influence any officer /employees of the purchaser for showing any favour in relation to this or any other contract shall render
- 33. Laws Governing the Contracts:** The contracts shall be governed by the laws of India for the time being in force. The contract shall be interpreted in accordance with these laws.
- 34. Termination of Contracts:** Time shall be the essence of the contract. The purchaser shall have the right to terminate the contract without any notice in part or in full in any of the following cases:
- a. The delivery of the material is delayed for causes not attributed to Force Majeure after the scheduled date of delivery.
  - b. The seller is declared bankrupt or becomes insolvent.
  - c. The delivery material is delayed due to causes of Force Majeure by more than reasonable time.
  - d. In case Performance Security is not furnished within the time period specified by the purchaser.
  - e. Supply in the case of successful Tenderer should strictly confirm to the specifications of the equipment being purchased.
  - f. Any change in Address /Telephone/Fax/e-mail of the tenderer should immediately be informed. The state of non-communication by the firm will make the offer liable for rejection.
  - g. Late /Delayed tenders shall not be considered at all. These will be returned to the firm as it is at their expenses. Post tender revision/correction shall also not be considered.
- 35. Acceptance or rejection of offer:** MD, CGMFP reserves the right to accept or reject any tender in part or full without assigning any reason thereof. The successful tenderer should submit order acceptance letter within 10 days from the date of issue.

- 36.** The supplier shall insure that intimation of dispatch about the stock is sent to the concerned Managing Director District Union on the day of dispatch only by quick service available so that the consignee is in a position to make necessary arrangement for taking delivery of the stock at the centre/ location where the stock have to be delivered by the suppliers, as per the supply order. Copy of such intimation should also be dispatched to Chhattisgarh State Minor Forest Produce (T & D) Co-operative Federation Ltd., Raipur on the same day.
- 37.** All legal proceedings, if necessity arises to initiate by any of the parties Chhattisgarh State Minor Forest Produce (T & D) Co-operative Federation Ltd. or supplier shall have to be lodged in Courts situated in Raipur.
- 38.** Any dispute arising in connection with this agreement not amicably settled, would be referred to the arbitrator i.e., three-member Committee appointed by Chhattisgarh Govt. Raipur who will act as sole arbitrator and the verdict of the arbitrator shall be final and binding on both the parties.
- 39.** The Chhattisgarh State Minor Forest Produce (T & D) Co-operative Federation Ltd. shall have the right to accept or reject any or all tenders without assigning any reason thereof.
- 40.** Allocation of quantity / destinations to any tenderer shall be at the sole discretion of the Managing Director, Chhattisgarh State Minor Forest Produce (T & D) Co-operative Federation Ltd.
- 41.** Any condition other than those mentioned above, shall not be accepted.
- 42.** Any conditional offer shall be rejected summarily.
- 43.** The Managing Director, Chhattisgarh State Minor Forest Produce (T & D) Co-operative Federation Ltd. reserves the right to increase or decrease or cancel quantity mentioned in the tender notice or supply order at any time without assigning any reason at the risk and cost of the suppliers/tenderer.
- 44.** There will not be any negotiation regarding the rates proposed in the tender form but if the rate quoted by the two or more tenderers is the same, the lowest tenderer will be decided by drawing the lottery after opening of the tenders.
- 45.** For the interpretation of the tender conditions, the decision of the Managing Director, Chhattisgarh State Minor Forest Produce (T & D) Co-operative Federation Ltd. will be final.

The above terms and conditions from 1 to 27 are accepted to us and these conditions will constitute the conditions of contract between me/us and Managing Director CG State MFP (T&D) Co-op. Federation, the moment our tender / proposal is accepted, and firm supply order is issued.

### Instructions for the Submission of the Online Tender

(Ref: Clause 18 of Tender Notice)

**Note: The following steps need to be carried out for online submission of the Tender. Detailed instructions for each of the steps are given in the Tenderer's Manual on the Home Page of <https://cgmpfdtenders.abcprocure.com>**

#### 1. Sequence of steps for online tender submission:

##### Step 1 – To obtain Digital Signature Certificate (DSC) :

The DSC is issued by an approved certifying authority, authorized by the Controller of Certifying Authorities (CCA), Government of India. The individual may obtain information required for issuance of a Class II / Class III DSC from the Controller of Certifying Authorities ([www.cca.gov.in](http://www.cca.gov.in)). The tenderer will have to obtain DSC from <https://cgmpfdtenders.abcprocure.com> or any other CCA approved agency.

DSC is issued upon receipt of mandatory identity proofs and verification letters attested by a Gazetted Officer. Only upon the receipt of the required documents, a DSC can be issued.

**Important Note:** The offers submitted online should be signed electronically with a DSC to establish the identity of the tenderer. In case, during the process of a particular tender, the user loses his/her DSC (eg. due to virus attack, hardware problem, operating system problem etc.) he may not be able to submit the offer online.
