1. INTRODUCTION

1.1 Project

Chhattisgarh State Minor Forest Produce (T & D) Co-operative Federation herein referred as “**Authority**” is in the process of developing trade & marketing channels to promote the sale of MFP based products manufactured in the designated production units of authorities in Chhattisgarh.

The Authority envisages to engage the private agencies for development of trade and marketing channels for its MFP based products by inviting proposal for empanelment with Authority. The empanelled buyers here in after referred as “**Applicant**” will promote trade and sale of MFP based products under their own brands through their offline and online sales & marketing channels.

1.2 Expression of Interest

Authority invites proposals through this EOI for empanelment of Buyers for procurement of MFP based products from Chhattisgarh State Minor Forest Produce (T & D) Co-operative Federation

1.3 Due diligence by Applicants

The Applicants are advised to inform themselves about the Project and the local conditions before submitting the Application

1.4 Procurement of EOI Document

1.5 Validity of the EOI

The proposals submitted by applicant shall be valid for a period of not less than 120 days.

1.6 Brief description of the Empanelment Process

The empanelment process is a single stage process for wherein, interested applicant is required to give presentation on the activities related with MFP products before the authority for empanelment. Authority shall score the applicant and based upon their presentation as per evaluation methodology defined in this EOI. After evaluation, as per the clause 4 (B), a list of MFP based products wise eligible applicants shall be prepared for empanelment.

Applicant should submit their proposal in the sealed envelope clearly indicating **“Proposal for Empanelment of Buyers for procurement of Minor Forest Produce (MFP) based products from Chhattisgarh State Minor Forest Produce (T & D) Co-operative Federation”** in bold letters on top of the envelope.

2. MINIMUM ELIGIBILITY CRITERIA

- a) The applicant should be a registered company/ legal entity/ society.
- b) The applicant should have requisite licenses/ certificates/ registrations to perform trade/ marketing/ processing of MFP based products listed in Annexure I.

2.1 Technical Eligibility

Applicant should have prior work experience in trading /processing/ marketing/ storage of MFP/ Herbal/ Agro-processing based products having registered office/ processing unit/ warehouse/ wholesale or retail network/ online presence on e-commerce platforms,

OR

Start-up recognized by Department for Promotion of Industries and Internal Trade (DPIIT), Government of India, related to Herbal/ Food Processing/ Agriculture and are willing to start their business in Minor Forest Produce based products' trade/ processing/ marketing.

2.2 Financial Eligibility

The applicant's registered company/ legal entity/ society should have positive Net worth and shall furnish details of the same (As per the format Appendix C),

OR

in case of newly registered entities who do not possess Net worth certificate as of now shall provide Net worth of the promoters/ directors of the registered company/ legal entity/ society,

OR

In case of start-up the promoter's certificate/ Individual Net worth shall be considered.

2.3 Supporting Documents for Eligibility Criteria:

- a) Certificate of incorporation and commencement of business or certificate of registration
- b) PAN CARD and GST Certificate
- c) CA certified Net worth Certificate as per Appendix C.

3. SUBMISSION OF APPLICATION

In addition to above mentioned supporting documents, the Applicant shall also submit the following documents

4. EMPANELMENT PROCESS

- a) The applicants who qualify as per the eligibility criteria will be invited for the presentation.

- b) The agenda for the presentation will be to understand wholesale, retail network of the buyer or their existing capacity to procure and market the product/s
- c) An applicant can be empaneled for one or more MFP based products (as per Annexure I)
- d) Listing of products will be done (Tentative list as per Annexure I) & empanelment for each MFP based product will be done separately
- e) On the basis of marks obtained in the presentation, the eligible applicants will get empaneled for procurement of MFP based products from the Federation
- f) All the applicants shall be scored and ranked based up on their experience and net worth in the trade and marketing of MFP products.
- g) The Undertaking submitted by the empaneled Buyers to procure minimum quantity of MFP based products from the Authority, shall be processed in order of merit and the first (1st) rank holder shall be processed first and respectively.
- h) The priority list will be updated on monthly basis after the completion of empanelment process keeping the priority order intact of already empaneled buyers through previous rounds of empanelment.

5. PERIOD OF EMPANELMENT

The applicant shall be empaneled for a period of 3 (Three) years which could be extendable by another 2 (two) years considering past performance, fulfillment of obligations (legal) and the terms & conditions mutually agreed up on between the Authority & Applicant.

The Authority reserves the right to issue a fresh notification anytime including validity duration of this EOI, to invite additional agencies for empanelment. The decision of Authority shall be final and binding to all the applicants submitting their proposal for this EOI.

6. QUANTITY OF SALE

- a) The applicant shall provide the quantity of MFP based products which they want to procure from Chhattisgarh State Minor Forest Produce (T & D) Co-operative Federation in one Financial Year (as per Appendix B)
- b) Authority shall undertake to provide the mentioned quantity as per the availability of MFP products.
- c) In case of multiple applicants for MFP based products and with limited availability with Authority, the decision shall be taken considering the ranking obtained by the applicant during the evaluation and Authority reserves the right to take a final decision for quantity of sale.
- d) The Authority's decision shall be final and binding to all the applicant while deciding the final quantity of sale.
- e) Tentative price list of MFP based products is attached in Annexure I, which is subjected to change as per market demands.
- f) The Authority provides the following options to the Buyer:
 - a. For Bulk Packaging: The Buyer has to arrange for bulk containers for lifting the products from the delivery centers.

- b. For Retail Packaging: The Buyer who are interested in retail packaging of products will have to bear additional cost for the required retail packaging material and labor expenses.

7. PROCUREMENT PRICE

- a) The Authority reserves the right to determine the price of finished product/s for sale. The price of MFP based products shall be revised every year by the Authority.
- b) List of finished products with the tentative sales price for the purpose of this EoI is provided in Annexure I (tentative sale price is subject to change at the Federations' discretion)
- c) The applicant has to make arrangement for lifting of MFP products from different units of authority at their own cost, Authority shall not provide any transport/cost associated with transportation of the finished products
- d) All the taxes and statutory charges shall be additional and as applicable.

8. SIGNING OF AGREEMENT

- a) The Authority will sign an agreement on Rs. 100 Non-Judicial stamp paper (cost of stamp paper will be borne by the empaneled buyers) with the empaneled buyers for a period of One year and the final quantity of sale will also be mentioned in the agreement (new sale agreement will be executed every year as per amended sale price of the products)
- b) **Security Deposit** - the empaneled buyer will have to deposit the performance Bank Guarantee amount in the form of security deposit to ensure proper execution of the agreement. Before signing the agreement with the empaneled buyer, 10% of Total Order Value as security deposit by demand draft/term deposit receipt in favor of "MD CGMFP Fed Raipur" from any commercial bank Payable at Raipur or Bank Guarantee valid for 12 months in favor of "MD CGMFP Fed Raipur".
- c) The Security Deposit may be adjusted against the balance dues (if any) towards the end of the agreement period.
- d) Violation of any Clause(s) of the agreement shall be deemed as violation of Terms and Conditions of EoI. This would result in forfeiture of Security Deposit. Further Buyer may be barred from participating in subsequent empanelment proceedings. Such suspension will be initiated without assigning any reason whatsoever.
- e) **Renewal of Agreement** – Security deposit will be refunded after the end of one year and fresh sale agreement will be executed as per amended sale price and quantity of sale. New Security Deposit based on amended sale price and quantity of sale will be deposited again before signing of the fresh agreement.
- f) Draft Agreement is attached herewith as Annexure II.

9. PROCESS OF SALE

- a) The delivery of the MFP based product will be done on Monthly Basis or as per the Mutual Agreement between the Buyer and the Seller.

- b) The empaneled Buyers will be communicated by the way of e-mail about the location of delivery center, details of the product, contact details of the authorized person at the delivery center of the MFP based product.
- c) The Buyers shall compulsorily provide details of authorized person (Name, ID card number, contact etc.) who would be taking the delivery on behalf of the empaneled Buyer
- d) Federation will certify the quality of the finished products on standard quality parameters (Organic/ FSSAI/ Ayush etc., whichever is applicable) along with shelf life of the product/s before the product is moved out from the warehouse/production unit.
- e) The empaneled Buyer who submits an undertaking to procure minimum assured quantity of MFP based product/s from the Federation within a financial year and deposit advance amount for the order with Federation will be given the priority over other empaneled buyers for delivery of the product. However, it will succeed the empaneled buyers ranked in the priority list from the previous rounds.

- f) In case multiple buyers are interested in the procurement of the same MFP based product, the capacity of buyer to procure the MFP based product from the Federation will be decided based on the Net worth of the company (or its promoters incase the company is a newly formed entity or Start-up). The federation will decide the quantity of the product which will be sold to the empaneled buyers.
- g) Apart from the Security Deposit, the buyer has to make full payment to the Seller for the requested order before taking the delivery of the product. (Ex: Suppose total order for one financial year is 1200 Quintals, monthly delivery will be of 100 Quintals. The buyer has to make the full payment for 100 Quintals before taking the delivery of the product)
- h) Once the final product has been lifted from the Warehouse/storage facility/production unit it will be sole responsibility of the buyer to ensure proper storage and handling of the products and federation will not be responsible for any deterioration in the product quality once the product moves out of the Warehouse/production unit

10. DELIVERY OF PRODUCTS

- a) The buyer shall make the full payment for the requested order by the way of electronic funds transfer to the Federation be taking the delivery of the product from the delivery center.

- b) It is liability of the empaneled buyer to pay any taxes including GST if any payable. Buyer shall pay, cost of packaging (if any applicable), transportation charges, transit insurance, and loading charges and other incidental expenses incurred for taking delivery at respective delivery center.
- c) The buyer will provide containers for taking delivery of the MFP based products and the same will be delivered unpacked in the given containers after proper weighing of the finished products. Delivery note will be given to Buyer with the details of the product and shelf life of the product.
- d) Any loss of finished products occurring during the transportation /in transit shall be solely buyer's responsibility.

11. LEGAL OBLIGATIONS OF THE PARTIES

- a) In no event will Seller's liability exceed the total amount paid by Buyer to Seller for the total of all the shipments for any cause of action or future claim.
- b) Buyer will acknowledge and agree that Seller is not liable for any special, indirect, consequential, or punitive damages, including but not limited to lost profits and/ or loss of business, arising out of or relating to the agreement in any way.
- c) The seller will not be responsible for any delay in providing the finished products to the buyer due to any unforeseen reasons for which the seller will notify the buyer within 15 days prior to the date of delivery.
- d) The finished products can be sold with different brands as preferred by the buyer and the seller will not be responsible for any legal claims afterwards i.e. once the final product moves out of the Warehouse/storage facility/ production units, the federation will not be liable for any claims related to legal, quality parameters of the product.
- e) Federation shall not be liable for any claims, disputes for the products once they are picked up by the buyer from the production facility
- f) Any license related to packaging, branding, storage, export, and any other certification will be sole responsibility of the buyer
- g) Federation will not be responsible for any license or certificate of the finished good once it gets dispatched from the Warehouse/storage facility/production unit.
- h) The buyer will not use any Brand/ Logo/ Design/ Name of "Chhattisgarh Herbals" or any entity associated with Federation. The buyer is prohibited to use CG Minor Forest Produce Cooperative Federation Limited's Name, Brand, Logo, Design for any product on their branding/ label or marketing channels.

And

Whereas

Buyer is a registered company/ legal entity/ society/ which is already working in processing, trading, storage, retail or wholesale of Food/ Herbal Products. And Buyer has wholesale/ retail network in the State of Chhattisgarh and has online presence in e-commerce platforms. and,

Buyer is a Start-up recognized by Department for Promotion of Industries and Internal Trade (DPIIT), Government of India, related to Herbal/ Food Processing/ Agriculture and are willing to start their business in Minor Forest Produce based products marketing.

Federation vide its Expression of Interest ("EOI") Notification No. <#> dated <> invited proposal for empanelment of Buyers for procurement of Minor Forest Produce (MFP) based products from the Federation.

Whereas the Buyer submitted its proposal for the aforesaid empanelment, whereby the Buyer represented to the Federation that it has required experience/ willingness and resources/capacity to procure MFP based products from the Federation on the terms and conditions as set forth in the EOI and this agreement;

Whereas the Federation on acceptance of the aforesaid proposals of the Buyer, issued its Letter of Acceptance ("LOA") letter No.<>

This agreement witnesses as follows:

1. Definition

- “Federation”** : Chhattisgarh State Minor Forest Produce (T&D) Cooperative Federation Limited.
- “Buyer”** : means empanelled person who buys or agrees to buy goods;
- “Contract of Sale”** : includes an agreement to sell as well as the sale;
- “Action”** : includes counterclaim and set-off;
- “Delivery”** : means voluntary transfer of possession from one person to another.
- “Fault”** : means a wrongful act or default.
- “Existing goods”** : includes all the minor forest produce based products notified by the Chhattisgarh State Minor Forest Produce (T&D) Cooperative Federation Limited, which are agreed to be severed before sale or under the contract of sale.
- “Future Goods”** : Any products which is notified by Chhattisgarh State Minor Forest Produce (T&D) Cooperative Federation Limited in addition to the existing product by the seller after the making of the contract of sale.
- “Property”** : means the general property in goods and not merely a special property.
- “Quality of Goods”** : includes their state or condition.
- “Sale”** : includes a bargain and sale as well as a sale and delivery.
- “Seller”** : means a person who sells or agrees to sell goods.
- “Specific Goods”** : means goods identified and agreed upon at the time a contract of sale is made.
- “Warranty”** : means an agreement with reference to goods that are the subject of a contract of sale but collateral to the main purpose of the contract, the breach of which gives rise to a claim for damages but not to a right to reject the goods and treat the contract as repudiated

- xi. Apart from the Security Deposit, the buyer agrees to make full payment to the Seller for the requested order before taking the delivery of the product. (Ex: Suppose total order for one financial year is 1200 Quintals, monthly delivery will be of 100 Quintals. The buyer has to make the full payment for 100 Quintals before taking the delivery of the product)

In case of any dispute arising out of change in the bank account detail authority shall communicate with the applicant clearly mentioned the details of bank account. For the purpose of trade of MFP based products of authority only electronics means of transactions is / are allowed.

- xiii. Once the final product has been lifted from the Warehouse/storage facility/production unit it will be sole responsibility of the buyer to ensure proper storage and handling of the products and federation will not be responsible for any deterioration in the product quality once the product moves out of the Warehouse/production unit.

3. DELIVERY OF THE FINISHED PRODUCTS

- i. It is liability of the empaneled buyer to pay any taxes including GST if payable. Buyer agrees to pay, cost of packaging (if any applicable), transportation charges, transit insurance, and loading charges and other incidental expenses incurred for taking delivery at respective delivery center.
- ii. The buyer agrees to provide containers for the MFP based products and the same will be delivered unpacked in the given containers after proper weighing of the finished products through available electronic weighing scale at the delivery center. Delivery note will be given to Buyer with full details of product. The tare weight of the empty containers will be recorded on the electronic weighing scale and after loading the gross weight will be recorded on the same electronic weighing scale and the net weight will be recorded in front of authorized representative at the delivery center
- iii. Any risk of loss/damage for the finished products on transportation will be the buyer's responsibility.
- iv. The Federation will not be responsible for any delay in providing the finished products to the buyer due to any unforeseen reason for which the seller will notify buyer 15 days before the date of delivery.

4. PERIOD OF AGREEMENT

This agreement shall be valid for a period of 12 months from the date of signing of Agreement. New agreement will be executed after one year with amended price of MFP based products.

5. CONFIDENTIALITY

- i. The Buyer shall keep confidential, any information related to this agreement, with the same degree of care as it would treat its own confidential information. The Buyer shall note that the confidential information will be used only for the purposes of this agreement and shall not be disclosed to any third party for any reason what-so-ever.

- ii. The Buyer should not disclose to any other party and keep confidential the terms and conditions of this empanelment agreement, any amendment hereof, and any Attachment or Annexure hereof.

6. LEGAL OBLIGATIONS OF THE FEDERATION

- i. The Federation will certify the quality of the finished products on standard quality parameters along with the shelf life of the product before the product is moved out from the warehouse/production unit. Federation will get the batch certified before the delivery of the product.
- ii. The Federation is not liable for any claims, disputes for the products once they are dispatched from the production facility.
- iii. The Federation will not be responsible for any license or certificate of the finished good once it gets dispatched from the Warehouse/storage facility/production unit.

7. LEGAL OBLIGATIONS OF THE BUYER

- i. The buyer agrees to not utilize any Brand/ Logo/ Design/ Name of "Chhattisgarh Herbals" or any entity associated with it. The buyer is prohibited to use CG Minor Forest Produce Cooperative Federation Limited's Name, Brand, Logo, Design for any product on their branding/ label or marketing channels.
- ii. The Buyer acknowledges and agrees that Seller is not liable for any special, indirect, consequential, or punitive damages, including but not limited to lost profits and/ or loss of business, arising out of or relating to the agreement in any way.
- iii. Any license related to packaging, branding, storage, export, and any other certification will be sole responsibility of the buyer .

8. PENALTY CLAUSE

The Federation reserves the right to impose penalty under following circumstances:

- i. If the buyer commits breach of any of the terms and conditions of this agreement, the Managing Director/ Authorized person of the Federation shall have the power to levy a penalty of Rs. 5,000/- (Five Thousand) for the first instance, Rs 10,000/- (Ten Thousand) for the second instance and Rs 15,000/- (Fifteen Thousand) for the third instance. Further after three instances of breach, any other instance of breach shall lead to forfeiture of the Security Deposit, termination (as per Termination Clause no 9) of the agreement and the empaneled buyer shall be removed from the empanelment list and shall be blacklisted by the Federation.
- ii. If the Buyer terminates the agreement before aforesaid period of one year or/and denies the procurement of the MFP based product from the Delivery center, the Security Deposit will be forfeited, the empaneled buyer shall be removed from the empanelment list and the organization will be blacklisted by the Federation.

9. TERMINATION CLAUSE

i. Right to Terminate the Agreement:

The Federation reserves the right to cancel the empanelment agreement with the empaneled Buyer and recover expenditure incurred by the Federation under the following circumstances:

- a. When the Buyer does not order (monthly/ quarterly or as decided) products for more than three pre-decided delivery intervals (monthly/ quarterly or as decided).
- b. If the Buyer commits breach of any of the terms and conditions of the agreement for more than three instances.
- c. If the Buyer goes into liquidation, voluntarily or otherwise.

- ii. The Federation reserves the right to recover any dues payable by the Buyer from any amount outstanding to the credit of the Buyer, including the pending bills by invoking the Security Deposit under this agreement.

- iii. Process of Termination: After the occurrence of any of the circumstances mentioned in clause 9(i), the Federation shall serve a notice to the Buyer. The Buyer shall respond to the notice within 15 days from the date of receipt. Upon receipt of response from the Buyer, the Federation shall take decision on Termination.

10. DISPUTE RESOLUTION MECHANISM

- i. The Buyer and the Federation shall endeavor their best to amicably settle all disputes arising out of or in connection with the Agreement in the following manner:
 - a. In case of any disputes relating to procurement of MFP based products by the empaneled Buyer including Clause/ Clauses of the EoI, the matter shall be referred to the Managing Director, CGMFPFED
 - b. The Party raising a dispute shall address to the other Party a notice requesting an amicable settlement of the dispute within seven (7) days of receipt of the notice.
 - c. In case any dispute between the Parties, does not settle by negotiation in the manner as mentioned above, the same may be resolved exclusively by arbitration and such dispute may be submitted by either party for arbitration within 20 days of the failure of negotiations. Arbitration shall be held in Raipur and conducted in accordance with the provisions of Arbitration and Conciliation Act, 1996 or any statutory modification or re-enactment thereof. Each Party to the dispute shall appoint one arbitrator each and the two arbitrators shall jointly appoint the third or the presiding arbitrator.

11. FORCE MAJEURE

Force Majeure is herein defined as any cause, which is beyond the control of the Buyer or Federation as the case may be which they could not foresee or with a reasonable amount of diligence could not have foreseen and which substantially affect the performance of the agreement, such as:

- i. Natural phenomenon, including but not limited to floods, droughts, earthquakes, and epidemics.

- ii. Acts of any government, including but not limited to war, declared or undeclared priorities, quarantines, embargos and terrorist attack, public unrest in work area.
- iii. The Buyer or Federation shall not be liable for delay in performing his/her obligations resulting from any force majeure cause as referred to and/or defined above provided either party shall within 10 days from occurrence of such a cause, notifies the other in writing of such causes.

12. LIMITATION OF LIABILITY

The aggregate liability of the Federation to the empaneled Buyer, whether under the Agreement, in tort, or otherwise, shall not exceed the amount of **Total Value of Order** as per the Agreement.

13. INDEMNITY

- i. The Buyer shall execute and furnish to the Federation, a Deed of Indemnity in favor of the Federation, in a form and manner acceptable to Federation, indemnifying Federation from and against any third-party costs, losses, damages, expenses, claims including those from third parties owing infringement or misappropriation of a patent, copyright, trademark and trade secret, arising or incurred inter- alia during and after the agreement period arising out of:
 - a. failure of the empaneled Buyer to comply with Applicable Laws and applicable permits;
 - b. payment of taxes required to be made by the empaneled Buyer to the Federation; or
 - c. non-payment of amounts due as a result of MFP based products furnished to the empaneled Buyer.

14. CONTINUANCE OF THE AGREEMENT

Notwithstanding the fact that settlement of dispute(s) (if any) under arbitration may be pending, the parties here to shall continue to be governed by and perform the work in accordance with the provisions under the Scope of Work, as defined in the EOI, to ensure continuity of operations.

15. CONFLICT OF INTEREST

The Buyer shall disclose to Federation in writing, all actual and potential conflicts of interest that exist, arise or may arise (either for the Buyer or the Buyer's team) in the course of performing the Service(s) as soon as practical after it becomes aware of that conflict.

16. SEVERANCE

In the event any provision of the Agreement is held to be invalid or unenforceable under the applicable law, the remaining provisions of this Agreement shall remain in full force and effect.

17. GOVERNING LANGUAGE

The Agreement shall be written in English language. Subject to below Clause, such language versions of the Agreement shall govern its interpretation. All correspondence and other documents pertaining to the Agreement that are exchanged by parties shall be written in English language only.

18. "NO CLAIM" CERTIFICATE

The Buyer shall not be entitled to make any claim, whatsoever against Federation, under or by virtue of or arising out of, the agreement, nor shall Federation entertain or consider any such claim, if made by the Buyer after it has signed a "No claim" certificate in favor of Federation in such form as shall be required by it after the Agreement period is over.

19. PUBLICITY

The Buyer shall not make or permit to be made a public announcement or media release about any aspect of this Agreement unless the Federation first give its written consent to the Buyer.

20. INTELLECTUAL PROPERTY RIGHTS (IPR)

- i. The Buyer shall not, without prior written consent from Federation, disclose/share/use the bid document, agreement, or any provision thereof, or any specification, plan, drawing, pattern, sample or information

furnished by or on behalf of the Federation, in connection therewith, to any person other than a person employed by the Buyer in the performance of the agreement. Disclosure to any such employed person shall be made in confidence and shall extend only as far as may be necessary for purposes of such performance.

- ii. The Buyer shall not, without prior written consent of Federation, make use of any document or information made available for the project, except for purposes of performing the Agreement.
- iii. The Buyer shall not use the Federation's name or name and addresses of any of its processing units, Brands, taglines or entities of Chhattisgarh Herbals for promotion or advertisement of the MFP based products.

21. GENERAL

i. Relationship between the Parties

- a. Nothing in the Agreement constitutes any fiduciary relationship between the Federation and Buyer Team or any relationship of employer employee, principal and agent, or partnership, between the Federation and Buyer.
- b. No Party has any authority to bind the other Party in any manner whatsoever except as agreed under the terms of the Agreement.
- c. Federation will not be under any obligation to the implementation of the work of the Buyer's Team except as agreed under the terms of the Agreement.

ii. **No Assignment:** The Buyer shall not transfer any interest, right, benefit or obligation under the agreement without the prior written consent of Federation.

iii. **Survival:** The provisions of the clauses of the Agreement in relation to documents, data, processes, property, Intellectual Property Rights, indemnity, publicity and confidentiality and ownership survive the expiry or termination of this Agreement and in relation to confidentiality, the obligations continue to apply unless Federation notifies the Buyer of its

release from those obligations.

- iv. **Entire Agreement:** The terms and conditions laid down in the EOI दस्तावेज़ dated <> and all annexures there to, Response to Pre-bid queries and also the Proposal/ Tender submissions(Technical & Financial) and any attachments/annexes there to shall be read in consonance with and form an integral part of the Agreement. - v. **Governing Law:** This agreement shall be governed in accordance with the laws of India and the State of Chhattisgarh.
- vi. **Jurisdiction of Courts:** The High Court of Chhattisgarh at Bilaspur, Chhattisgarh has exclusive jurisdiction to determine any proceeding in relation to the Agreement.
- vii. **Compliance with Laws:** The Selected Buyer, during the course of performing the agreement, shall comply with the laws in force in India and the State of Chhattisgarh during the duration of the agreement.
- viii. **Notices:** A “notice” means:
 - a. notice; or
 - b. Consent, approval or other communication required to be in writing under the Agreement. All notices, requests or consent provided for or permitted to be given under this Agreement shall be in writing and shall be deemed effectively given when personally delivered or mailed by pre-paid certified/registered mail, return receipt requested, addressed as follows and shall be deemed received two days after mailing or on the date of delivery if personally delivered:
