- 3. (i) Tenders are to be submitted only online in the prescribed Tender Forms only for Technical Bid (Annexure – I) and Financial Bid (Annexure - II).
  - (ii) The tenderer will propose in Financial Bid the rate (inclusive of Basic Rate, G.S.T and Other Taxes if any should be mentioned) F.O.R destination including all taxes i.e., Goods and Services Tax and surcharge and the Local Bodies Taxes if any on F.O.R destination basis. - 7. Decision of the Managing Director of the Federation to declare any of the tenderer to have or have not qualified in Technical Bid shall be final and binding on the tenderer. Intimation of decision of the competent authority shall be conveyed to the tenderers.

8. Financial Bid of only those tenderers who qualify in the pre-qualification shall be opened and Financial bid of only those tenderers will be considered whose sample(s) is/are conforming to the Technical specifications provided by the Federation in Section 1 and has been approved by the technical committee constituted for the purpose. - 9. Earnest Money Deposit (EMD): The tenderer will have to make the online payment of total amount of EMD as shown in Clause 4 of the tender notice. If the tenderer is applying the tender for the supply / installation of one (1) Item, EMD amount pertaining to that particular item will have to be deposited by the tenderer. #### 13. Person Authorised to Submit Bid

- (i) Person or persons signing the tender form shall state in what capacity he or she or they are signing the tender form e.g., as sole proprietor of the firm concerned or as Managing Director or Director or Secretary of Limited Company. - 14. A bidder shall not have conflict of interest. All bidders found to have conflict of interest shall be disqualified. A bidder may be considered to be in conflict of interest with one or more parties in this bidding process, if, including but not limited to:
  - a) They have controlling shareholders in common or
  - b) They receive or have received direct or indirect subsidy from any of them or
  - c) They have the same legal representative for purposes of this bid or
  - d) They have a relationship with each other, directly or through common third parties,

# TERMS AND CONDITIONS OF THE SUPPLY, INSTALLATION AND HANDS-ON TRAINING OF HYBRID SOLAR DRYERS / NETS/ CRATES FOR MAHUA FLOWERS AND OTHER MFP'S (Second Round)

- 1. The supplier / tenderer shall be deemed to have carefully examined the terms and conditions, specifications, etc. of the goods to be supplied. If he has any doubt as to the meaning of any portion of the conditions, specifications he may, refer to the Managing Director, Chhattisgarh State Minor Forest Produce (T & D) Co-operative Federation Ltd., and get clarification.
- 2. The supplier / tenderer shall not assign or sub-let his contract or any substantial part thereof to any other agency without the approval of Managing Director, Chhattisgarh State Minor Forest Produce (T & D) Co-operative Federation Ltd.
- 3. All the stocks supplied shall be of best quality and conform to the specifications as per tender document, trademark laid down for them and strictly in accordance with the approved standard samples. The decision of the Managing Director, Chhattisgarh State Minor Forest Produce (T & D) Co-operative Federation Ltd. shall be binding upon the supplier and in case of any article supplied is not being approved, then expenses or loss caused to M.F.P. Federation as a result of rejection or replacement of supplies, shall be entirely to the account of the supplier.
- **4.** The Managing Director, Chhattisgarh State Minor Forest Produce (T & D) Co-operative Federation Ltd. or his duly authorized representative shall at all reasonable time access and examine the materials and workmanship of the goods.
- In case goods /items other than of the approved specifications, quality, make or size are supplied, the same shall have to be replaced immediately by the supplier without extra cost. Any expenses or loss caused to M.F.P. Federation on whose behalf purchase has been made, shall be on account of the supplier.
- 6. The supplier should ensure that the goods/items are inspected and approved by the Inspection Agency authorized by Federation to ascertain the quality material primarily. At the time of loading, the supplier should ensure that the seals of the Inspection Agency are intact on all the equipment. The inspection and sealing charges of inspection agency will be borne by CGMFPFED. If in the inspection, the goods are not found in conformity with the given specification / approved quality, make or size as per the Technical Specifications as per Section 1 of the Tender Document, the same will be rejected and the supplier shall have to replace the same immediately without any extra cost. Any expenses incurred / loss suffered by CGMFP Federation on this a/c shall be debited to the supplier's a/c.

CGMFPFED can also conduct a joint inspection if required and in case joint inspection is not carried out along with the surveyor within the given time, it would be presumed that the complaints made by the consignees are quite genuine and loss sustained by the consignees, shall be recovered from the supplier.

- 7. The CGMFP has the right to have a demonstration of the equipment/item in his premises. The supplier has to abide by this condition. The demonstration has to be arranged by the supplier at his own cost.
- 8. The rejected goods/items/articles must be removed by the supplier from the destination wherever they may be, within fifteen days of the date of inspection. The Purchaser concerned will take care of such goods/items/materials but in case of delay the purchaser shall not be responsible for any loss, shortage, damage, etc.
- 9. The supplier shall be responsible for the proper standard packing so as to avoid damage under normal conditions of transport by road and shall ensure delivery of the materials in good condition to the consignee at respective centers. In the event of any loss, damage, torn / cut or any shortage found on checking / inspection of the materials by the consignee, the same shall be debited to the supplier's account.
- 10. The Proposed rate (inclusive of Basic Rate, G.S.T and Other Taxes if any should be mentioned) and will be valid up to 45 days from the date of opening of Technical Bid.
- 11. The Managing Director Chhattisgarh MFP Federation can repudiate the contract of supply at any time, at the risk and cost of the supplier, if the supplies are not made up to satisfaction of CG State MFP (T&D) Co-op. Federation.
- 12. The successful bidder will have to submit a Performance security of equivalent to 3% of the Contract /Order value before the issue of award letter valid till 60 days beyond the period of expiry of the Warranty/ Guarantee period in shape of crossed Demand Draft/Pay order/Fixed Deposit Receipt/Bank Guarantee from a commercial bank in favor of the CGMFP Raipur, payable at Raipur. The performance security will remain valid till expiry of warranty period. This will be released beyond 60 days after completion of warranty period. If the security deposit is not deposited within the specified time, the supply order will be cancelled, the EMD will be forfeited and the tenderer may be blacklisted for future transactions with Federation by the Managing Director Chhattisgarh MFP Federation, Raipur for a maximum period of 3 years. No interest shall be paid by CG State MFP (T&D) Co-op. Federation on such security deposit.
  - **13.** Remittance charges on payment made to the supplier will be borne by the supplier.
  - **14.** Supply & Installation / Delivery Schedule: The supplies shall be made strictly as per the following schedule
    - i. Delivery and final installation required: For Indian manufacturer Within 30 days from the Date of issue of award letter or as specified in the supply order;

If the supplier fails to supply the dryers/ nets/ crates according to the time schedule specified in firm order, it will be treated as breach of terms and conditions and will result in forfeiture of full/part EMD / Security Deposit by Managing Director, Chhattisgarh State Minor Forest Produce (T & D) Co-operative Federation Ltd., Raipur and further render the supplier responsible and liable for damage/loss specially the extra cost incurred by the purchaser for procurement of the unsupplied material from open market. The value of damage/loss will be assessed by the Managing Director, Chhattisgarh State Minor Forest Produce (T & D) Co-operative Federation Ltd., Raipur and will be final and binding on the supplier. In addition, the supplier can also be blacklisted by the Managing Director, Chhattisgarh State Minor Forest Produce (T & D) Co-operative Federation Ltd., Raipur for future transactions with Federation for a maximum period of 5 years.

- **15.** The dryers/ nets/ crates will be supplied/ installed at different places in the Chhattisgarh, which are listed in the bid in Annexure III.
- **16.** Supply/ installation and hands on training of dryers/ nets/ crates will be done by the supplier free of cost.
- **17.** The dryer/ nets/ crates will be used for other forest produce also. Therefore, only new LDPE sheets of high quality must be ensured by the supplier.
- **18.** Operating manual of 1-2 page written in Hindi should be provided with the Solar Hybrid Dryer.
- 19. The cost of damage, if any during transportation and installation will be borne by the supplier.
- **20.** A warranty of one year will be given by the supplier for any manufacturing defect in the structure of Solar Hybrid Dryer (except for LDPE sheet) and nets.
- 21. Any change / corrigendum/ extension of opening date in respect of this tender shall be issued through websites only and no press notification will be issued in this regard. Bidders are therefore requested to regularly visit our website for updates..
- 22. Penalty for Delayed Services / Liquidated Damages: In case the firm does not complete the supply within the laid down agreed delivery period as per contract, liquidated damages will be charged @ 0.5% per week or part thereof subject to a maximum of 10% of the contract value. However, the CGMFP reserves the right to either further extend or cancel the contract after expiry of delivery date and recover the liquidated damages from the dues of the firm by legal means.

#### 23. Evaluation of Tender: Single bidding process is adopted

#### **Pre-Qualification**

- i. Evaluation of Technical Bids to assess their suitability against the laid down parameters in this tender notice
- ii. Tenderers must ensure that they enclose all original technical literature and detailed documentary proofs which specifically bring out the compliance of the equipment being offered against the technical specifications mentioned in the tender notice. If necessary, the Tenderers may be directed to give a presentation for evaluation by a technical committee constituted for the purpose.
- iii. In case it is not possible to verify compliance of equipment as per technical bid due to lack of adequate documents, in original no reference will be made to tenderer and the bid will not be considered further and treated as cancelled.

#### **Opening of Financial Bid**

- i. The price bids of only those firms, found meeting the laid down specifications in pre-qualification and eligibility criteria shall be opened, evaluated and considered further.
- ii. It is in the tenderers interest to include all relevant and detailed technical data as supporting documents along with their bid.
- iii. The Financial bid will be considered in individual manner for all the items specified in clause 4 of the tender notice.
- iv. Item wise, Lowest Financial proposal (L1) shall be declared successful bidder provided that the samples provided by the concerned bidder conform to the specifications provided in Section 1 of the Tender notice.
- **24. Insurance:** As applicable in the case of imported goods. For indigenous item it will be responsibility of the supplier to supply the material in good condition on FOR basis without

involving the risk of the purchaser. The equipment to be supplied will be insured by the vendor against all risks of loss or damage from the date of shipment till such time it is delivered at site of installation.

#### 25. Conflict of Interest

- a. The Agency is required to provide professional, objective and impartial advice and at all times hold the CGMFPFED's interest paramount, strictly avoid conflicts with other assignment/jobs or their own corporate interest and act without any consideration for future work.
- b. Without limitation on the generality of the foregoing, Agency and any of their affiliates, shall be considered to have a conflict of interest under any of the circumstances set forth below:
  - i. **Conflicting Assignment/job:** An Agency (including its affiliates) shall not be hired for any assignment/job that, by nature, may be in conflict with another assignment/job of the
  - ii. Agency to be executed for the same or for another Employer.
  - iii. **Conflicting Relationships:** An Agency that has a business or family relationship with a member of the CGMFPFED staff who is directly or indirectly involved in any part of the project shall not be awarded the Contract, unless the conflict stemming from this relationship has been resolved in a manner acceptable to the CGMFPFED throughout the selection process and the execution of the Contract.
  - iv. **Conflicting Activities**: An Agency or any of its affiliates, selected to provide consulting assignment/job for this project shall be disqualified from subsequent downstream supply of goods or works or services resulting from or directly related to this project.
  - v. Agency have an obligation to disclose any situation of actual or potential conflict that impacts their capacity to serve the best interest of CGMFPFED, or that may reasonably be perceived as having this effect. Any such disclosure shall be made to CGMFPFED, immediately. If the Agency fails to disclose said situations and if the CGMFPFED comes to know about any such situation at any time, it may lead to the disqualification of the Agency during bidding process or the termination of its contract during execution of the assignment.
- **26. Payment:** 80 % (Eighty Percent) Payment shall be made on bill basis after supply, satisfactory installation, commissioning and performance of the equipment at designated locations in Chhattisgarh and after certification by the concerned with regards to the compliance of supplied goods/items as per Technical Specifications mentioned in Section 1 of the Tender Document and remaining 20 % (Twenty Percent) payment shall be made upon satisfactory completion of Handson Training
- **27. Terms of Delivery:** FOR District Union locations in the state of Chhattisgarh (Details provided in **Annexure-III**)
- **28. Inspection After Receipt of Goods/items:** The inspection will be done by the Committee in the presence of the firm representative. The successful tenderer will have to provide at his own cost and arrangement technically qualified personnel at the consignee's location for joint inspection. These personnel must be able to unpack, assemble and demonstrate the use of the equipment fully and identified each Part/Machines supplied. Any consumables that are essential will be provided by the supplier free of cost.
  - In case of receipt of materials in damaged condition the suppliers will have to arrange the replacement of goods/items free of cost. All expenses in this regard will be borne by the supplier.
- 29. Packing & Marking: The packing and preservation of the supplied goods shall be roadworthy so that it may provide their safety during transit period. The supplier shall guarantee that the packing is strong enough to withstand the safety of the goods during transport. The packing should satisfy the security seal in the clearing warehouse and shall carry the fragile or other markings as required. All damages which may occur as a result of defective packing shall be borne by the seller.

- **30.** Compliance Statement: The firms must submit compliance statement-cum-technical bid in the format given in Technical specifications and drawings failing which their offer will be treated as incomplete and is liable to be rejected.
- 31. Guarantee /Warranty: Comprehensive onsite warranty is required. Warranty Terms period will start from the date of installation of items. In case at installation stores/part of stores are found defective /damaged during or after delivery to consignee, the suppliers will replace or repair the store under warranty at consignee's location in India free of cost or if any case it is required to be sent back to the foreign manufacturer. Bank Guarantee equivalent to the cost of equipment is required to be submitted before lifting the store. All expenses in this regard will be borne by the supplier.
- **32. Dispute settlement:** The dispute arising out of this contract shall be subject to the jurisdiction of Indian laws & court at Raipur. Sole arbitrator is appointed by the MD, CGMFP and his decision will be final and binding to both parties (Supplier and Purchaser).
- **33. Training:** One day training will be given by the supplier. All expenses in this regard will be borne by the supplier. For Solar Dryer the supplier will have to provide hands-on-training for the operation and handling of solar dryer to the operators at its own cost
- **34. Price:** The price quoted shall be on firm and fixed basis and should be reasonable leaving no scope for any further negotiation on price. CGMFP is exempted from payment of excise duty. Hence, excise duty will not be paid to the firm. For sales tax, CGMFP is not authorized to issue Sales Tax Form C&D; CGMFP is exempted from payment of Custom Duty
- 35. Penalty for use of undue influence: The seller should undertake that he has not given offered or promised to give directly or indirectly any gift, consideration, reward, commission, fees brokerage of inducement to any person in service of the Purchaser or otherwise in procuring, the contract or forbearing top do or for having done or for borne to do any act in relation or execution of the contract or any other contracts with the CGMFP for showing or for bearing to show favor or disfavor to any person in relation to the contract or any other contract in the CGMFP. Any breach of the aforesaid undertaking by the seller or any one employed by him or acting his behalf whether with or without the knowledge the seller or the commission of any offers by the seller or any one employed or acting on his behalf, as defined in Chapter-IX of the IPC, 1860 or the Prevention of Corruption Act, 1947 or any other Act enacted for the Prevention of Corruption shell entitle the purchase to cancel the contract and all or any other contract with the CGMFP seller and recover from the seller the amount of any loss arising from such cancellation. A decision of the purchaser or his nominee to the effect that a breach of the undertaking had been committed shall be final and binding on the seller.

Giving or offering of any gift, bribe or inducement or any attempt at any such act on behalf of the seller towards any officer /employee of the purchaser or to any other person in a position to influence any officer /employees of the purchaser for showing any favor in relation to this or any other contract sell render

- **36.** Laws Governing the Contracts: The contracts shall be governed by the laws of India for the time being in force. The contract shall be interpreted in accordance with these laws.
- **37. Termination of Contracts:** Time shall be the essence of the contract. The purchaser shall have the right to terminate the contract without any notice in part or in full in any of the following cases:
  - a. The delivery of the material is delayed for causes not attributed to Force Majeure after the scheduled date of delivery.
  - b. The seller is declared bankrupt or becomes insolvent.

- c. The delivery material is delayed due to causes of Force Majeure by more than reasonable time.
- d. In case Performance Security is not furnished within the time period specified by the purchaser.
- e. Supply in the case of successful Tenderer should strictly confirm to the specifications of the equipment being purchased.
- f. Any change in Address /Telephone/Fax/e-mail of the tenderer should immediately be informed. The state of non-communication by the firm will make the offer liable for rejection.
- g. Late /Delayed tenders shall not be considered at all. These will be returned to the firm as it is at their expenses. Post tender revision/correction shall also not be considered.
- **38.** Acceptance or rejection of offer: MD, CGMFP reserves the right to accept or reject any tender in part or full without assigning any reason thereof. The successful bidder should submit order acceptance letter within 10 days from the date of issue.
- 39. The supplier shall insure that intimation of dispatch about the stock is sent to the concerned Managing Director District Union on the day of dispatch only by quick service available so that the consignee is in a position to make necessary arrangement for taking delivery of the stock at the center / location where the stock have to be delivered by the suppliers, as per the supply order. Copy of such intimation should also be dispatched to Chhattisgarh State Minor Forest Produce (T & D) Co-operative Federation Ltd., Raipur on the same day.
- **40.** All legal proceedings, if necessity arises to initiate by any of the parties Chhattisgarh State Minor Forest Produce (T & D) Co-operative Federation Ltd. or supplier shall have to be lodged in Courts situated in Raipur.
- **41.** Any dispute arising in connection with this agreement not amicably settled, would be referred to the arbitrator i.e., three-member Committee appointed by Chhattisgarh Govt. Raipur who will act as sole arbitrator and the verdict of the arbitrator shall be final and binding on both the parties.
- **42.** The Chhattisgarh State Minor Forest Produce (T & D) Co-operative Federation Ltd. shall have the right to accept or reject any or all tenders without assigning any reason thereof.
- **43.** Allocation of quantity / destinations to any tenderer shall be at the sole discretion of the Managing Director, Chhattisgarh State Minor Forest Produce (T & D) Co-operative Federation Ltd. The proposed supply work may be increased as per need of this office
- **44.** Any condition other than those mentioned above, shall not be accepted.
- **45.** Any conditional offer shall be rejected summarily.
- **46.** The Managing Director, Chhattisgarh State Minor Forest Produce (T & D) Co-operative Federation Ltd. reserves the right to increase or decrease or cancel quantity mentioned in the tender notice or supply order at any time without assigning any reason at the risk and cost of the suppliers/tenderer.
- **47.** There will not be any negotiation regarding the rates proposed in the tender form but if the rate quoted by the two or more tenderers is the same, the lowest tenderer will be decided by drawing the lottery after opening of the tenders.
- **48.** For the interpretation of the tender conditions, the decision of the Managing Director, Chhattisgarh State Minor Forest Produce (T & D) Co-operative Federation Ltd. will be final.

#### Annexure – V

#### **Instructions for the Submission of the Online Tender**

(Ref: Clause 19 of Tender Notice)

Note: The following steps need to be carried out for online submission of the Tender. Detailed instructions for each of the steps are given in the Tenderer's Manual on the Home Page of https://cgmfpfedtenders.abcprocure.com

#### 1. Sequence of steps for online tender submission:

#### Step 1 – To obtain Digital Signature Certificate (DSC):

The DSC is issued by an approved certifying authority, authorized by the Controller of Certifying Authorities (CCA), Government of India. The individual may obtain information required for issuance of a Class II / Class III DSC from the Controller of Certifying Authorities (<a href="www.cca.gov.in">www.cca.gov.in</a>). The tenderer will have to obtain DSC from <a href="https://cgmfpfedtenders.abcprocure.com">https://cgmfpfedtenders.abcprocure.com</a> any other CCA approved agency.

DSC is issued upon receipt of mandatory identity proofs and verification letters attested by a Gazetted Officer. Only upon the receipt of the required documents, a DSC can be issued.

**Important Note:** The offers submitted online should be signed electronically with a DSC to establish the identity of the tenderer. In case, during the process of a particular tender, the user loses his/her DSC (e.g., due to virus attack, hardware problem, operating system problem etc.) he may not be able to submit the offer online. Hence the users are advised to back up the certificate and keep the copies at safe places under proper security to be used in case of emergencies.

In case of online tendering, the DSC issued to the authorized user of a firm and used for electronic tendering will be considered equivalent to no-objection certificate / power of attorney to that user. The firm has to authorize a specific individual via an authorization certificate signed by all partners to use the DSC as per Indian *IT Act 2000*. Unless the certificate is revoked, it shall be assumed to represent adequate authority of the user to submit tender on behalf of the firm for the Chhattisgarh State Minor Forest Produce (Trading & Development) Co-op. #### (ii) Any other relevant documents-
