**TENDER NOTICE FOR E-PROCUREMENT OF HYBRID SOLAR DRYER, NETS, AND  
CRATES FOR MAHUA FLOWER AND OTHER MFPS FOR THE SEASON 2023**

1. Online Tender on e-Procurement Portal <https://cgmpfed.abcprocure.com> as in Annexure – I (Technical Bid) and Annexure - II (Financial Bid) are invited only from manufacturers / Vendors for the Establishment/ Procurement - supply, installation, provision of hands-on training of Solar Hybrid Dryers/ Collection nets/ crates as per specification given in **Section 1** by Chhattisgarh State Minor Forest Produce (Trading & Development) Cooperative Federation Limited.
2. Tender notice along with **Section 1, Annexure-I, II, III, IV, V and VI** giving detailed specification / delivery schedule etc, can be seen and downloaded from Federation's website [www.cgmpfed.org](http://www.cgmpfed.org) and e-Procurement portal <https://cgmpfedtenders.abcprocure.com> only.
3. (i) Tenders are to be submitted only online in the prescribed Tender Forms only for Technical Bid (Annexure – I) and Financial Bid (Annexure - II).  
  
(ii) The tenderer will propose in Financial Bid the **rate (inclusive of Basic Rate, G.S.T and Other Taxes if any should be mentioned)** F.O.R destination including all taxes i.e., Goods and Services Tax and surcharge and the Local Bodies Taxes if any on F.O.R destination basis. (Delivery locations (Destination) of all the items as mentioned in clause 4 below is provided in Annexure IV.

5. The Tenderer shall submit online Technical and Financial Bid in separate Technical Bid Envelope and Financial Bid Envelope respectively mentioned in **Annexure - V**.
6. The tenderer should upload certified photocopies of all the documents required in this tender notice. The tender shall be accepted up to **15.00 hrs. on 07.02.2023** and Bid shall be opened online in this office only at **15.10 hrs. on 07.02.2023** even if it is a public holiday by the duly constituted Committee.
7. Decision of the Managing Director of the Federation to declare any of the tenderer to have or have not qualified in Technical Bid shall be final and binding on the tenderer. Intimation of decision of the competent authority shall be conveyed to the tenderers.

8. Financial Bid of only those tenderers who qualify in the pre-qualification shall be opened and Financial bid of only those tenderers will be considered whose sample(s) is/are conforming to the Technical specifications provided by the Federation in Section 1 and has been approved by the technical committee constituted for the purpose. Details of samples to be submitted for each item is mentioned below. Samples should reach Federation on or before the last date of submission of Bid or any extension provided by Federation

9. Earnest Money Deposit (EMD): The tenderer will have to make the online payment of total amount of EMD as shown in Clause 4 of the tender notice. If the tenderer is applying the tender for the supply / installation of one (1) Item, EMD amount pertaining to that particular item will have to be deposited by the tenderer. In case where the tenderer is applying for more than one item/s then the total EMD amount which will be equivalent to the sum of all the items for which tenderer is applying for. **Illustration: In case of application for supply / installation of two items, sum of EMD amount applicable for Item 1 “Solar Dryer” (INR 1,25,000.00) and Item 2&3 “HDPE Monofilament (7.5 M X 15 M and 9 M X 18 M” stitched net) (INR 1,25,000.00) i.e., total EMD amount INR 2,50,000.00 will have to be deposited by the Tenderer.** The bid/s will summarily be rejected if there is any discrepancy in the amount of EMD that is required to be deposited. **For example:** If tenderer has applied bid for 3 (three) items and has deposited the EMD amount for only 2 (two) items the bid shall not be considered for evaluation. 10. The rate offered by the tenderer in the Financial Bid will be valid up to forty-five days from the date of opening of the Financial Bid but not later than 75 days of opening of the Technical Bid.

**11. Rate should be clearly mentioned in the Financial Bid in figures only. The tenderer can bid for one / more than one / all the item categories mentioned in clause 4 and clause 10 of this tender notice and pay the EMD accordingly.**

**12. Eligibility Criteria**

i. The tenderer should be Original Equipment Manufacturer (**Submit firm registration certificate, or any other certificate issued by State/Central Government to establish that the bidder is an OEM.**)

Or

The tenderer should be Authorised Dealer of Original Equipment Manufacturer (**Submit Authorization letter from OEM/MoU/agreement signed between the OEM & the authorized dealer**)

ii. The Bidder's should have Minimum Annual Average Sales from supply of Dryer / Net / Crates or related material to the Govt./PSU/Company/ Partnership Firm/ Proprietorship/ LLP etc., during the last three years (i.e., 2019-20, 2020-21, 2021-22) as below

**In case tenderer offers bid for more than one item the minimum turnover of each of the respective item should be met to qualify his bid for evaluation as per 12 (ii) above. In case of shortfall of minimum sum of the sales for the items the bidder bids, the offer shall stand disqualified.**

- iii. Tenderer must Upload the User list of the respective equipment/items or similar installations made elsewhere on the letter head of the bidder.
- iv. The tenderer must have latest GST/VAT/Sales Tax Clearance certificate along with copy of Registration certificate under Sales Tax.
- v. The tender from principal firm and authorized agent/dealer will not be accepted together.
- vi. The tenderer must submit the blacklisting certificate indicated that their firm is not blacklisted from any Government Organization.
- vii. As per section 139A of the Income Tax Act, 1961, enclosing of scanned copy of PAN card is compulsory for the tenderer.
- viii. Enclosing of Scanned copy of Aadhaar Card issued by Unique Identification Authority of India. (UIDAI) is compulsory. Scanned copy of Aadhaar Card of Managing Director of the Company and in case of Partnership firm Aadhaar Card of at least two of Partners required, in case of Hindu Undivided Family (HUF) Aadhaar Card of Karta and one adult family member is to be enclosed.

### 13. Person Authorised to Submit Bid

(i) Person or persons signing the tender form shall state in what capacity he or she or they are signing the tender form e.g., as sole proprietor of the firm concerned or as Managing Director or Director or Secretary of Limited Company. In the case of partnership firm, the names of all the partners should be recorded and the tender form should be signed by all the partners or their duly constituted attorney having authority to bind all partners in all matters pertaining to the contract as recorded in the power of attorney or in the partnership deed. True copy of the Registered "Partnership Deed" should be uploaded along with the tender form failing which the tender shall be liable to be rejected. It shall be obligatory on the part of every partner of the firm, which enters into agreement to fulfil the terms and conditions of the agreement during the currency of the contract thereof, notwithstanding the dissolution of the partnership in the meantime, In the case of a limited company, the tender form shall be signed by a person empowered to do so by the company, copy of Certificate of incorporation of the company and the letter authorizing the person signing the tender documents shall be uploaded to the tender form failing which the tender shall be liable to be rejected. In the case of Hindu undivided family, the names of the family members should be uploaded with the tender form and 'Karta' who can bind the family should sign the tender form.

(ii) The person signing the tender form on behalf of another or on behalf of a Firm shall enclose with the tender form power of attorney or deed duly executed in his favour or the partnership deed giving him such power showing that, he has the authority to bind such other person or the firm, as the case may be in all matters pertaining to the contract. If the person so signing the tender form fails to upload the said power of attorney or partnership deed, his tender shall be liable for summary rejection. The power of attorney should be signed by all the partners in the case of partnership concerns, by the proprietor in case of a proprietary concern and by the person who by his signature can bind company in the case of limited company. In the case of Hindu undivided family, the power of attorney should be signed by the 'Karta' who by his signature can bind the family.

14. A bidder shall not have conflict of interest. All bidders found to have conflict of interest shall be disqualified. A bidder may be considered to be in conflict of interest with one or more parties in this bidding process, if, including but not limited to:

- a) They have controlling shareholders in common or
- b) They receive or have received direct or indirect subsidy from any of them or
- c) They have the same legal representative for purposes of this bid or
- d) They have a relationship with each other, directly or through common third parties,
- e) that puts them in a position to have access to information about or influence on the bid of another bidder or
- f) A bidder participates in more than one bid in this bidding process. Participation by a bidder in more than one bid will result in the disqualification of all bids in which the party is involved.
- g) A bidder participated as a consultant in the preparation of the design or technical specification of the contract that is subject of the bid

15. The bids submitted online should be signed electronically with a Digital Certificate to establish the identity of the tenderer tendering online. The tenderer can obtain the Digital Signature Certificate as per the instructions of step 1 of clause 1 of enclosed Annexure - V.

16. In order to participate in the tender, the tenderer is required to get registered on the e-Procurement portal (<https://cgmpfed.abcprocure.com>). Only after online registration of the tenderer, the tenderer shall be allowed to participate in the tenders floated by the C.G.M.F.P

Federation using the e-Procurement System. After obtaining the Digital Certificate as mentioned in above S.No. 15 and successfully installed on their system, the tenderer have to be online registered through “New Bidder Registration” page of the e-Procurement portal (<https://cgmfpfed.abcprocure.com>) and mapped their Digital Certificate.

17. The Instructions for submission of online tender (Annexure - V) for tenderers to submit the online tenders will be available on e-Procurement portal <https://cgmfpfed.abcprocure.com> and the online tender can be submitted as per time and date mentioned in time schedule (Annexure - VI).
18. The tenderers will have to submit (Upload Scan Copies / fill) his / her offer / credentials online as required in the tender in the online templates in relevant envelopes.
19. The tenderers may refer User Manual for tenderers available online to perform their online activities. (Annexure V)
20. The Managing Director, Chhattisgarh State Minor Forest Produce (Trading & Development) Co-operative Federation Limited reserves the right to accept / reject any or all the tenders without specifying any reason thereof. He may relax any tender condition.
21. Conditional offer other than on our terms and conditions shall not be accepted.
22. SUPPLIERS WHO MAY NOT BE IN A POSITION TO MAKE TIMELY SUPPLIES OF QUALITY MATERIAL ACCORDING TO TENDER SPECIFICATION AND GOOD FINISH SHOULD NOT BID.
23. Tenderers who are selected after opening of the financial bid have to supply the equipment/ items/ goods within 15 days of release of sanction letter.
24. For the interpretation of the tender conditions, the decision of the Managing Director of Chhattisgarh State M.F.P Federation will be final. In case of any clarification, the tenderer may contact the Managing Director, Chhattisgarh State Minor Forest Produce (Trading & Development) Co-operative Federation Limited, Raipur.
25. All the terms & conditions of this tender notice will be binding on the supplier / tenderer.

#### **Solar Hybrid Dryer (2000 kg/batch)**

**Capacity:** 2000 kg/batch (Based on fresh mahua flower, Aamchur, Amla, Nagarmutha, Giloy etc.)

**Chamber size:** approximately 10×6×3 m (L×W×H at center), up to 2 m height at sides, and may vary as per capacity

Temperature rise up to 70°C

Construction of drying chamber on sturdy frame of GI pipes (minimum 25 mm diameter or more for different kind of frameworks).

Chamber covered with minimum 200 micron UV stabilized clear HDPE film

**Heating system:** Hybrid

Tubular solar heat exchanger of suitable capacity for hot air generation

**Blower:** Minimum 2 Nos. or more depending upon requirement

Fitted with at least one turbo fan at the top of chamber

**Electric heater:** approximately 5 kW

### **Specifications of Net for collection of mahua flower (As per IS: 10054, 1996):**

- High density polyethylene (HDPE) monofilament netting, round/square mesh fabric.
- Number of holes per cm<sup>2</sup>: 16 to 20.
- Mass of net: 80±5 g/m<sup>2</sup> or higher
- Bursting strength of string: 83 N or more
- Width of fabric: 1.2 m (minimum)
- Length in a bundle: 130 m

**TERMS AND CONDITIONS OF THE SUPPLY, INSTALLATION AND HANDS-ON TRAINING OF HYBRID SOLAR DRYERS / NETS/ CRATES FOR MAHUA FLOWERS AND OTHER MFP'S**

1. The supplier / tenderer shall be deemed to have carefully examined the terms and conditions, specifications, etc. of the goods to be supplied. If he has any doubt as to the meaning of any portion of the conditions, specifications he may, refer to the Managing Director, Chhattisgarh State Minor Forest Produce (T & D) Co-operative Federation Ltd., and get clarification.
2. The supplier / tenderer shall not assign or sub-let his contract or any substantial part thereof to any other agency without the approval of Managing Director, Chhattisgarh State Minor Forest Produce (T & D) Co-operative Federation Ltd.
3. All the stocks supplied shall be of best quality and conform to the specifications as per tender document, trademark laid down for them and strictly in accordance with the approved standard samples. The decision of the Managing Director, Chhattisgarh State Minor Forest Produce (T & D) Co-operative Federation Ltd. shall be binding upon the supplier and in case of any article supplied is not being approved, then expenses or loss caused to M.F.P. Federation as a result of rejection or replacement of supplies, shall be entirely to the account of the supplier.
4. The Managing Director, Chhattisgarh State Minor Forest Produce (T & D) Co-operative Federation Ltd. or his duly authorized representative shall at all reasonable time access and examine the materials and workmanship of the goods.
5. In case goods /items other than of the approved specifications, quality, make or size are supplied, the same shall have to be replaced immediately by the supplier without extra cost. Any expenses or loss caused to M.F.P. Federation on whose behalf purchase has been made, shall be on account of the supplier.
6. The supplier should ensure that the goods/items are inspected and approved by the Inspection Agency authorized by Federation to ascertain the quality material primarily. At the time of loading, the supplier should ensure that the seals of the Inspection Agency are intact on all the equipment. The inspection and sealing charges of inspection agency will be borne by CGMFPFED. 9. **Note: The following steps need to be carried out for online submission of the Tender. Detailed instructions for each of the steps are given in the Tenderer's Manual on the Home Page of <https://cgmpfdtenders.abcprocure.com>**

#### 1. Sequence of steps for online tender submission:

##### Step 1 – To obtain Digital Signature Certificate (DSC):

The DSC is issued by an approved certifying authority, authorized by the Controller of Certifying Authorities (CCA), Government of India. The individual may obtain information required for issuance of a Class II / Class III DSC from the Controller of Certifying Authorities ([www.cca.gov.in](http://www.cca.gov.in)). The tenderer will have to obtain DSC from <https://cgmpfdtenders.abcprocure.com> or any other CCA approved agency.

DSC is issued upon receipt of mandatory identity proofs and verification letters attested by a Gazetted Officer. Only upon the receipt of the required documents, a DSC can be issued.

**Important Note:** The offers submitted online should be signed electronically with a DSC to establish the identity of the tenderer. In case, during the process of a particular tender, the user loses his/her DSC (e.g., due to virus attack, hardware problem, operating system problem etc.) he may not be able to submit the offer online. Hence the users are advised to back up the certificate and keep the copies at safe places under proper security to be used in case of emergencies.
