**TENDER NOTICE FOR E-PROCUREMENT OF HONEY PROCESSING PLANT (SUPPLY,  
INSTALLATION, TESTING AND HANDS-ON TRAINING)**

1. Online Tender on e-Procurement Portal <https://cgmfpfedtenders.abcprocure.com> as in **Annexure – I (Technical Tender) and Annexure - II (Financial Tender)** are invited from eligible tenderers for Supply, Installation, Testing and Hands-on Training of Honey Processing Plant as per specification given in **Section 1** by Chhattisgarh State Minor Forest Produce (Trading & Development) Cooperative Federation Limited.
2. **3. Pre-Bid Conference**

4. (i) Tenders are to be submitted only online in the prescribed Tender Forms only for **Technical Tender (Annexure – I) and Financial Tender (Annexure - II)**.

(ii) The tenderer will propose in Financial Tender the **rate (inclusive of Basic Rate, G.S.T and Other Taxes if any should be mentioned)** F.O.R destination including all taxes i.e., Machines and Services Tax and surcharge and the Local Bodies Taxes if any on F.O.R destination basis. (Delivery locations (Destination) of the Honey Processing Plant as mentioned in **clause 5** below is provided in **Annexure IV**.)

5. **The requirement details for Honey Processing Plant are as follows:**

6. The Tenderer can quote for the tender according to his capacity to Install, Supply, Testing and Hands-on Training of Honey Processing Plant.
7. The Tenderer shall submit online Technical and Financial Tender in separate Technical Tender Envelope and Financial Tender Envelope respectively mentioned in **Annexure – V**
8. The tenderer should upload certified photocopies of all the documents required in this tender notice. The tender for first round shall be accepted up to **15.00 hrs. on 21.03.2023** and Tender shall be opened online in this office only at **15.10 hrs. on 21.03.2023** even if it is a public holiday by the duly constituted Committee.
9. Decision of the Managing Director of the Federation to declare any of the tenderer to have or have not qualified in Technical Tender shall be final and binding on the tenderer. Intimation of decision of the competent authority shall be conveyed to the tenderers.
10. Financial Tender of only those tenderers who qualify in the pre-qualification shall be opened.
11. The financial evaluation of the bids submitted will be inclusive of all the components as per specifications mentioned in Section 1 for the Honey Processing Plant. The Financial tender of the bidder quoting lowest rate (L1) will be awarded the work.
12. **Earnest Money Deposit (EMD):** The tenderer will have to make the online payment of EMD as shown in Clause 5 of the tender notice. EMD amount as shown in Clause 5 of the Tender notice will have to be deposited by the tenderer. The tender/s will summarily be rejected if there is any discrepancy in the amount of EMD that is required to be deposited as mentioned in clause 5 of the Tender Notice. EMD has to be deposited through payment gateway service provider in any of the following ways -
- A. **Credit Card / Debit Card (VISA / Master / Maestro Cards)** - The tenderer after selecting the option of the Credit Card / Debit Card (VISA / Master / Maestro Cards) make the online payment, as per the instructions of payment mentioned in the payment gateway.

- B. **Net Banking** - Tenderer can make the payment only from the bank account in having net banking facility. The list of banks for net banking will appear in the payment gateway and tenderer should select his bank from that list and make the payment as per the instructions given in the payment gateway.
- C. **RTGS / NEFT** - The tenderer can make the payment as per the instructions of clause 2.2 of enclosed **Annexure - V**.

The EMD of successful bidder shall be adjusted in the performance security. The E.M.D. of unsuccessful tenderers will be returned online only in the Bank Account mentioned in the point no. 12 of Form No. 1 **Annexure – I** only. No interest on E.M.D. will be paid in any circumstances.

- 13. The rate offered by the tenderer in the Financial Tender will be valid up to forty-five days from the date of opening of the Financial Tender but not later than 75 days of opening of the Technical Tender.
- 14. Rate should be clearly mentioned in the Financial Tender in figures only. The tenderer can tender for the Machine mentioned in clause 5 of this tender notice and pay the EMD accordingly.

#### 15. Eligibility Criteria

##### A) Technical and Financial Capacity criteria

- i. The tenderer should be Original Equipment Manufacturer (**Submit firm registration certificate, or any other certificate issued by State/Central Government to establish that the bidder is an OEM.**)

**Or**

The tenderer should be Authorised Dealer of Original Equipment Manufacturer (**Submit MoU/agreement signed between the OEM & the authorized dealer**)

- ii. The Bidder should have supplied, installed and commissioned **minumum two units of Honey Processing Plant** to the Govt./PSU/Company/ Partnership Firm/Proprietorship/LLP etc., during the last five years (**i.e., 2017-18, 2018-19, 2019-20, 2020-21 and 2021-22**)

**Work/purchase/supply order along with BOQ/Specification issued from the client (Govt./PSU/Company/ Partnership Firm/Proprietorship/LLP etc.) or satisfactory working certificate from the user/client to be submitted by the bidder.**

- iii. The Minimum Annual Turnover of the bidder should **be 40 lakh in anyone (1) of the last five financial years (i.e. 2017-18, 2018-19, 2019-20, 2020-21 and 2021-22) (Balance sheet and Profit and loss account and Turnover Certificate duly signed and certified by CA having UDIN number must be enclosed).**
- iv. Bidder must submit the list of the clients to whom Honey processing Plant was supplied in the past on its letter head with contact number etc.

- v. The tenderer is required to upload all the applicable documents specified in Form No. 4
  - vi. The tender from principal firm and authorized agent/dealer will not be accepted together.
  - vii. The tenderer must submit the declaration in their letter head indicated that their firm is not blacklisted from any Government Organization.
  - viii. As per section 139A of the Income Tax Act, 1961, enclosing of scanned copy of PAN card is compulsory for the tenderer.
  - ix. Enclosing of Scanned copy of Aadhaar Card issued by Unique Identification Authority of India. (UIDAI) is compulsory. Scanned copy of Aadhaar Card of Managing Director of the Company and in case of Partnership firm Aadhaar Card of at least two of Partners required, in case of Hindu Undivided Family (HUF) Aadhaar Card of Karta and one adult family member is to be enclosed.
16. The CGMFP has the right to have a demonstration of the Machine/equipment in his premises. The supplier has to abide by this condition. The demonstration has to be arranged by the supplier at his own cost.
17. **Delivery of Machines** - Within 60 days from the Date of issue of award letter or as specified in the supply order.

**18. Person Authorised to Submit Tender**

- i. Person or persons signing the tender form shall state in what capacity he or she or they are signing the tender form e.g., as sole proprietor of the firm concerned or as Managing Director or Director or Secretary of Limited Company. In the case of partnership firm, the names of all the partners should be recorded and the tender form should be signed by all the partners or their duly constituted attorney having authority to bind all partners in all matters pertaining to the contract as recorded in the power of attorney or in the partnership deed. True copy of the Registered "Partnership Deed" should be uploaded along with the tender form failing which the tender shall be liable to be rejected. It shall be obligatory on the part of every partner of the firm, which enters into agreement to fulfil the terms and conditions of the agreement during the currency of the contract thereof, notwithstanding the dissolution of the partnership in the meantime, In the case of a limited company, the tender form shall be signed by a person empowered to do so by the company, copy of Certificate of incorporation of the company and the letter authorizing the person signing the tender documents shall be uploaded to the tender form failing which the tender shall be liable to be rejected. In the case of Hindu undivided family, the names of the family members should be uploaded with the tender form and 'Karta' who can bind the family should sign the tender form.
- ii. The person signing the tender form on behalf of another or on behalf of a Firm shall enclose with the tender form power of attorney or deed duly executed in his favour or the partnership deed giving him such power showing that, he has the authority to bind such other person or the firm, as the case may be in all matters pertaining to the contract. If the person so signing the tender form fails to upload the said power of attorney or partnership deed, his tender shall be liable for summary rejection. The power of attorney should be signed by all the partners in the case of partnership concerns, by the proprietor in case of a proprietary concern and by the person who by his signature can bind company in the case of limited company. In the case of Hindu undivided family, the power of attorney should be signed by the 'Karta' who by his signature can bind the family.

19. A bidder shall not have conflict of interest. All bidders found to have conflict of interest shall be disqualified. A bidder may be considered to be in conflict of interest with one or more parties in this bidding process, if, including but not limited to:
- a) They have controlling shareholders in common or
  - b) They receive or have received direct or indirect subsidy from any of them or
  - c) They have the same legal representative for purposes of this bid or
  - d) They have a relationship with each other, directly or through common third parties,
  - e) that puts them in a position to have access to information about or influence on the bid of another bidder or
  - f) A bidder participates in more than one bid in this bidding process. Participation by a bidder in more than one bid will result in the disqualification of all bids in which the party is involved.
  - g) A bidder participated as a consultant in the preparation of the design or technical specification of the contract that is subject of the bid.
20. EMD shall be adjusted in the performance security. The successful tenderer will have to submit a Performance security of equivalent to 3% of the Contract /Order value, prior to the execution of agreement, valid till completion of one year from the date of commencement of commercial operation of the Honey processing Plant in shape of crossed Demand Draft/Pay order/Fixed Deposit Receipt/Bank Guarantee from a commercial bank in favour of the CGMFP Raipur, payable at Raipur. The performance security will remain valid till date of completion of one year from the date of commencement of commercial operation of the Honey processing Plant. This will be released after completion of one year from the date of commencement of commercial operation of the Honey processing Plant. If the security deposit is not deposited within the specified time, the letter of award will be cancelled, the EMD will be forfeited and the tenderer may be blacklisted for future transactions with Federation by the Managing Director Chhattisgarh MFP Federation, Raipur for a maximum period of 3 years. No interest shall be paid by CG State MFP (T&D) Co-op. Federation on such security deposit.
21. The tenders submitted online should be signed electronically with a Digital Certificate to establish the identity of the tenderer tendering online. The tenderer can obtain the Digital Signature Certificate as per the instructions of step 1 of clause 1 of enclosed **Annexure - V**.
22. In order to participate in the tender, the tenderer is required to get registered on the e-Procurement portal (<https://cgmfpfedtenders.abcprocure.com>). Only after online registration of the tenderer, the tenderer shall be allowed to participate in the tenders floated by the C.G.M.F.P Federation using the e-Procurement System. After obtaining the Digital Certificate as mentioned in above S.No. 20 and successfully installed on their system, the tenderer has to be online registered through "New Tenderer Registration" page of the e-Procurement portal (<https://cgmfpfedtenders.abcprocure.com>) and mapped their Digital Certificate.
23. The Instructions for submission of online tender (**Annexure - V**) for tenderers to submit the online tenders will be available on e-Procurement portal <https://cgmfpfedtenders.abcprocure.com> and the online tender can be submitted as per time and date mentioned in time schedule (**Annexure - VI**).

24. The tenderers will have to submit (Upload Scan Copies / fill) his / her offer / credentials online as required in the tender in the online templates in relevant envelopes.
25. The tenderers may refer User Manual for tenderers available online to perform their online activities. **(Annexure V)**
26. The Managing Director, Chhattisgarh State Minor Forest Produce (Trading & Development) Co-operative Federation Limited reserves the right to accept / reject any or all the tenders without specifying any reason thereof. He may relax any tender condition.
27. Conditional offer other than on our terms and conditions shall not be accepted.
28. SUPPLIERS WHO MAY NOT BE IN A POSITION TO MAKE TIMELY SUPPLIES OF QUALITY MACHINES ACCORDING TO TENDER SPECIFICATION AND GOOD FINISH SHOULD NOT TENDER.
29. Tenderers who are selected after opening of the financial tender have to supply the equipment/ machines within 60 days from the date of issue of supply order.
30. For the interpretation of the tender conditions, the decision of the Managing Director of Chhattisgarh State M.F.P Federation will be final. In case of any clarification, the tenderer may contact the Managing Director, Chhattisgarh State Minor Forest Produce (Trading & Development) Co-operative Federation Limited, Raipur.
31. All the terms & conditions of this tender notice will be binding on the supplier / tenderer.
32. The amendments in this tender notice are possible. ## **Section 1**

### **SPECIFICATIONS FOR ONE UNIT OF HONEY PROCESSING PLANT CAPACITY: 500 KG PER BATCH (8 HOURS SHIFT)**

<b>Components</b>	<b>Description</b>
<b>Pre filter Tank</b>	<p>Rectangular or Circular Tank made of SS 304 material having holding capacity of around 550 kgs. The Material of construction shall be SS 304 with Sloping Opening at the Centre, so that no honey remains in this tank on completion of the process. The Opening of Tank shall be covered with Steel Mesh of 400 Micron and the Lower Bottom Opening shall be fitted with SS ball Valve of 1". The Steel Mesh shall be removable and easy to clean. The tank shall be of suitable thickness and sturdy to withstand the weight of heavy honey cans, used for charging honey. The outlet of tank is connected to gear pump.</p> <p><b>This Tank have a Provision of Level Rise Tube at outer to Check the Honey Level from Outside with Calibrated Scale over it which show Amount of Honey left inside the tank in kg.</b></p>
<b>Gear Pump</b>	<p>The gear pump shall be of stainless steel. This gear pump shall be coupled with 1:40 reduction gear box, and driven by 1 HP motor. The piping is also in full 304 food grade Stainless Steel. The outlet of the raw honey pump shall split into 2 directions, both controlled by 1" ball valves. One of the lines going back to pre-filter tank, while the other goes into the Pre heating tank. Basic Output Capacity of Gear Pump shall be (2000- 2500) lts/hr. Reduction gear Box to operate gear pump at desired output.</p> <p><b>They Rotating part inside the Gear Pump have a SS 316 Material and Need a Certificate for same.</b></p>
<b>Pre-Heating Tank (PHT)</b>	<p>This is a tube type heat exchanger device. The material of construction shall be SS 304 Food grade. In this tank honey passes through food grade SS steel pipe, which is surrounded by hot water. The arrangement to heat the honey passing through the pipe to 45° C, either by circulation of hot water from separate hot water tank, or uniform heating arrangement done on the pre heating tank itself. The arrangements shall be so that there shall be no drop of temperature in continuous run. Temperature sensor shall be provided, to cut off heaters or hot water circulation when the right temperature is achieved, and also to start back the heaters when temperature drops below the desired level. Heater Capacity should be such that the desired temperature is attained within 30 minutes and maintained throughout the process. Temperature gauge shall be provided to accurately measure the temperature of honey at this stage. The Outer Surface of Tank shall be thermally Insulated. The cut off limit shall be set at 48°C and 42°C shall be restart temperature. set up a device to read the honey temperature at the exit, if the temperature is acceptable then the solenoid opens and allows the honey to flow ahead else the honey is sent to pre filter tank and it continues to do so till it achieves the right temperature. The honey is then flowed in the filtration system when temperature is achieved.</p>

<b>Filtration</b>	Full stainless-steel self-locking high pressure filter having poly propylene filters made of 20-micron size. These will be <b>2 parallel filters</b> with 100-, 40- and 20-micron Filter Each. If one chokes, second one will start with a buzzer Alert to clean the first. All the filters are fitted with sensors so that if some filter gets choked the sensor will cut off the flow valve and the honey will be diverted to the pre filter tank. This also will give a buzzer and an indicator will glow on the control panel showing the filter /s has choked up and need clean up.
<b>Processing Tank</b>	This shall be shell and tube type or any other which is suitable for viscous fluids. The honey having temperature of 45°C coming from preheating tank is heated to 60°C. Honey should flow in a thin form enclosed in ss pipe coiling or ss plates, in a chamber or shell maintained at 65°C. The material of construction shall be SS 304 food grade. The coil/tube /plate in the system shall be tested for any leak before installing which shall be demonstrated before the demonstrator of the buyer to avoid any breakdown and loss of time and material after installation. Temperature gauge shall be provided to accurately measure the temperature of honey at this stage. Heater Capacity should be such that the desired temperature is attained within 30 minutes and maintained throughout the process. The proper valves shall be provided for easy control of flow rate.
<b>Moisture Reduction</b>	Falling film evaporator, where honey will flow in form of a thin film, so that maximum moisture reduction is achievable. The temperature of vacuum evaporation shall be 60°C±2°C. Subjected to (710 to 730) mm HG vacuum by means of high-capacity vacuum pump and self-controlled heating. Honey is to just pass through the system and shall not be held still in the moisture reduction unit to avoid overheating. The moisture reduced honey shall pass to the cooling tank.
<b>Cooling Tank</b>	This is also a tube type heat exchanger, but without heaters, instead it has a cooling system (a Cooling water from Chilling Plant) which runs on water circulation pump of 0.5 Hp. Temperature of Cooling Water shall be 15° C±2°C. Temperature Gauge shall be provided at the outlet of cooling tank of Chilling to read the temperature of water at inlet to cooling tank of Honey. It should be noted that the efficiency is partially depended on the effective cooling of honey.
<b>Special Lobe Pump</b>	A special lobe pump with seals to prevent vacuum leak shall be fitted in the line to pass the moisture reduced honey to the settling tank. RPM shall be fixed through motor pully. arrangement as required.
<b>Moisture condensation Unit</b>	This is a very thick walled (3mm thick SS 304) drum with dished bottom and top. Volume approx. 30% of the rated capacity of the plant. This drum has top entry and bottom exit with 1 more entry for vacuum connection. On the top entry there is a flange to connect to another condensing unit which has a helical coil of SS pipe. This pipe coil is submersed in cold water which comes from Chilling plant at Temperature of 15° C±2°C and circulated with a pump of 0.5 Hp.
<b>Condensate Trap</b>	2 condensate tanks of 20 ltr capacity of appropriate thickness to withstand (710 to 730 mm of HG vacuum) shall be provided.
<b>Settling tank</b>	Settling tanks have a Capacity to store of 550 kg with a level Pipe and Scale over it. There will be <b>6 Settling tanks</b> so that honey can settled for 6 days without shifting honey. Settling Tank also have a Inverted Conical Screw type Vent for release of air. Tanks shall have manhole arrangement for easy cleaning. Shall be fitted with 1" drip cut valves. A separate drain also should be provided at the bottom, which is plugged for use during washing of the settling tanks.



<b>Vacuum Pump</b>	Capacity of Vacuum Pump shall be such that easily achieve Vacuum in between (710-740) mm of Hg. Solenoid valve should be provided near vacuum pump on vacuum line, so that when there is power failure it will open automatic and release vacuum from honey tanks, thus preventing honey from entering condenser.
<b>Chilling Plant</b>	Chilling Plant with basin capacity necessary to cool the honey to room temperature instantly. Should have a Cooling Capacity of 3 ton of refrigeration.
<b>Flow Meter</b>	There will be <b>2 set of flow meters</b> , 1 at inlet of pre heating tank and 1 at exit of honey cooling tank, before the special pump, so that the flow rate of honey can be controlled. Flow Meter Can Easily able to read 30 kg/hr to 90kg per hour.  During the installation, the position may be changed to position where appropriate display is achieved.
<b>Honey Liquefier</b>	If the honey is granulated it is used to liquefy, before taking in the plant. This shall be square SS Tank, fitted with strong grill 9 inches from bottom. 4 KW heater with thermostat to cut off at 65°C shall be fitted at the bottom. It should have capacity to hold 4 Nos, 50 kg honey drums. The liquefier shall be mounted on iron trolley for easier movement 1 inch drain with cock should be provided for draining water.

1. **Any components/equipment/device required for smooth running of the plant must be considered**
2. All the Component of Machine, Pipes and Joints shall be made of SS 304 Food Grade Material or better and need a Certificate for same.
3. The Honey holding tanks shall be of appropriate gauge to withstand pressure/vacuum as applicable and shall not deform under pressure/vacuum.
4. The piping shall be of 1" dimension, made of SS 304, or better.
5. This plant shall give 6 % moisture reduction at or less than 62°C.
6. This Plant will have total input time of 8 hour per shift of 500 kg of raw honey including the time of water heating in Pre heating tank, Processed tank and Moisture Reduction Tank.
7. The plant shall have such arrangement that, on completion of process no honey shall remain in the plant.
8. **HMF shall NOT increase more than 5 PPM in the process.**
9. The Vacuum Pressure shall be **at 710 mm of Hg or Above** During the Entire Process.
10. The samples for testing shall be collected and sealed before the committee, before sending for testing.
11. **The Honey Processing Plant supplier should provide the illustrative Operating Manual and also should provide the blue print of the HPP, clearly showing the design, Material of make and dimension both external and internal of components and devices.**
12. **The manufacturer shall provide minimum Two-year warranty against manufacturing defects and free after sales service for two years.**

Federation as a result of rejection or replacement of supplies, shall be entirely to the account of the supplier.

**Note:** The following steps need to be carried out for online submission of the Tender. Detailed instructions for each of the steps are given in the Tenderer's Manual on the Home Page of <https://cgmpfedtenders.abcprocure.com>

#### 1. Sequence of steps for online tender submission:

##### Step 1 – To obtain Digital Signature Certificate (DSC):

The DSC is issued by an approved certifying authority, authorized by the Controller of Certifying Authorities (CCA), Government of India. The individual may obtain information required for issuance of a Class II / Class III DSC from the Controller of Certifying Authorities ([www.cca.gov.in](http://www.cca.gov.in)).
